John MacKinnon (Chairman) opened the meeting with a welcome to all.

1. MINUTES

The minutes of the last AGM held on 19th June 2023 were agreed as being a true representation of the meeting were proposed by A Morrison, and seconded by Maggie Wilkinson were duly signed.

2. CHAIRMAN'S REPORT.

Mr J MacKinnon delivered his report. (See attached)

Mr MacKinnon reported that it had been a good year for the Trust with many projects being funded and that just three applications were unsuccessful as they did not fit the criteria set out in the Trusts guidelines and so could not be funded.

He told the meeting that the Trustees had met often in the past year as they progress with the new CLG (Company Limited by Guarantee) and are in the stages of finalising details of the **Articles** of **Association** with their solicitors **Roberts LLP**

He thanked all Trustees for giving so much of their time this past year on behalf of the community. Mr MacKinnon invited questions from the floor.

No questions were raised

Mr MacKinnon handed the meeting over to the Treasurer

3. TREASURER'S REPORT

Audited accounts to 31st March 2024 had been completed, Mr Beaton went through the report, (See attached copy)

The balance in the Current Account at 31st March 2024 was £147,860.35.

He reported that as at the 1st April 2024 £14,969.58 had been granted in applications making the balance at the date of this meeting £132,890.77 with Vattenfall Community Payment Grant expected next month of around £54,000.

Mr A Morrison enquired at the AGM in 2023 how much in total that had been granted to the community since the Trust began in 2010.

Mr Beaton advised that the total amount is £473,472.93

Mr Beaton also confirmed that accounts had been audited and a

copy is available for the meeting to peruse.

Mr Beaton invited questions from the floor.

No questions were raised.

Accounts were proposed by **Mr Geoff Semler** and seconded by **Niall Till** and duly signed.

4. APPOINTMENT OF FINANCIAL ADVISORS

Messrs Donald Rankin was proposed to continue by John MacKinnon, seconded by Doanld Beaton

5. APPOINTMENT OF TRUSTEES

Mr MacKinnon handed the meeting over to the secretary, Alison Munro. Mrs Munro stated that two Trustees were obliged to stand down this year – Mr John MacKinnon and Alexander MacPhie. three completed nomination forms were received by the secretary. **Mr John MacKinnon**,

Mrs Munro advised that a **Community Election** would be required to be held. Mrs Munro stated that due to the **General Election** the **Highland Council Election Officer** would be unable to assist and advise her until after the general election which could be a number of weeks.

Mr MacKinnon advised that unless one of the nominees was willing to retracted their nomination that the Trustees would be unable to conduct business until an election could be carried out as office bearers could not be appointed. **Mr Geoff Semler** advised the Trustees should be able to conduct business with five remaining Trustees as they make up a majority.

The Trustees could not verify this advice and said that they would have to check if this was correct.

Mr Charteris addressed the meeting and said that he would be willing to retract his nomination. Mr MacKinnon thanked him and will contact him once he has more information to hand.

6. CLG UP-DATE

Mr MacKinnon told the meeting that the Trustees have a final draft of the **Articles of Association** from their solicitors but the Trustees have not been able to meet to discuss it but will do as soon they have dates available.
